





- DASH had selected WSP as consultant for this study. Project team consists of WSP, DASH, and City staff.
- Project Kickoff Meeting held December 8, 2020.
- As of January 11th, the project team is concluding Task 2: Compilation of known data.
- Tasks to be completed throughout the Spring of 2021:
 - Task 3: Facilities Assessment
 - Task 4: Short Range Infrastructure & Equipment Needs
 - Task 5: Analysis of Charger Location/Facility Layout
- Final report expected to be completed by end of May 2021,

General Manager's Reports ZEB Implementation Study

- All six depot chargers have been completed and approved by City inspection. Proterra charger commissioning will coincide with the delivery of the Proterra buses.
- Three New Flyer Zero Emissions Buses are currently in regular service
 - Early data reports that the buses are consuming approximately 3.0-3.4 kwh per mile in the current cold weather, with upwards of 35% of the energy being consumed for cabin heat.
- First Proterra bus is currently nearing end of production and is being prepared for inspections. The first unit is expected to be delivered towards the end of the month.

FY 2021 Projection

- ATC is on track through one-third of FY21.
 - CARES Act revenue transfers occurred in Dec.
 - Working closely with partners in the City's Finance Department and OMB.
- GM now recommending return to fare collection in March 2021, meaning about \$220k in additional CARES Act funds projected to be used in FY21 vs. FY22.
- CARES Act will ensure we end the year even at our current reduced service pattern.

Consolidated Appropriations Act, 2021

- Recent relief legislation includes \$14 billion for transit nationwide.
 - This includes roughly \$700 million for WMATA
 - It appears a portion will be shared with local bus operators, like CARES Act
