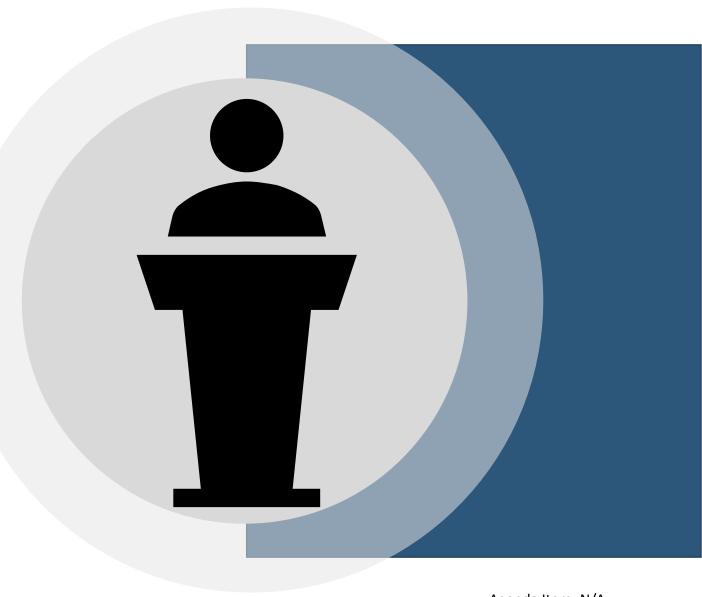

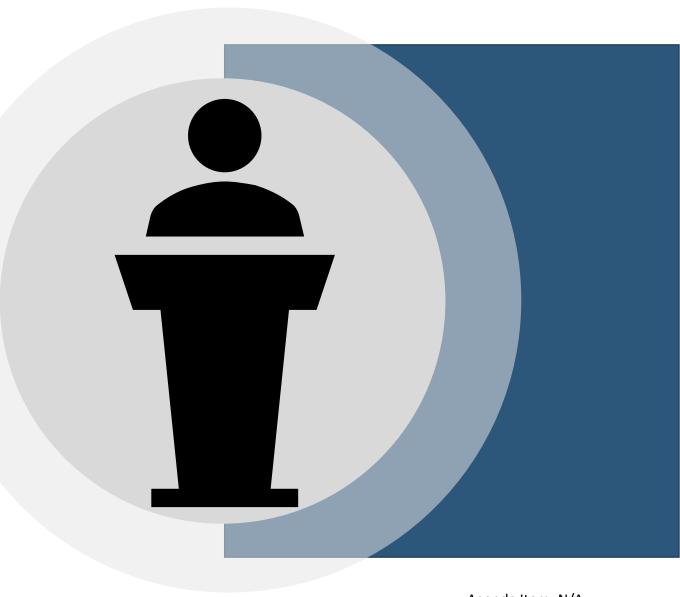

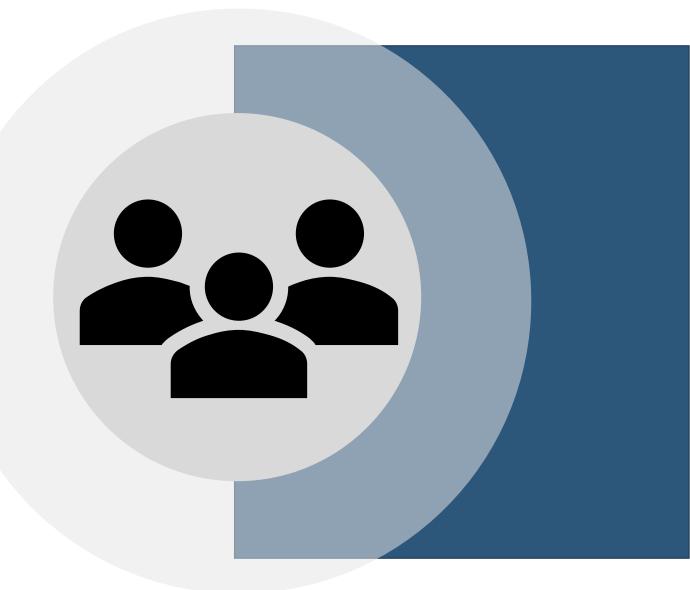

DASH ELECTRIC FLEET STRATEGY UPDATE

Progress: 14 battery electric buses in operation for 5+ years (regional

leader) with goal to be fully zero-emission by 2037.

Challenge: Manufacturer of 7 buses (Proterra) filed for bankruptcy.

Potential impacts: delayed repairs, reduced support.

Reality: Bus manufacturer market is narrow & unpredictable. Recent

exits (Novabus, ENC) highlight the issue.



DASH ELECTRIC FLEET STRATEGY UPDATE

DASH Mitigation Strategies:

- Fleet diversification to avoid relying on single supplier.
- Industry standards adoption for interoperability.
- Robust specifications for common components.
- Technician training to reduce reliance on OEM support.
- Data infrastructure investments for independent management.

Advocacy & Collaboration:

- DASH actively advocates for industry improvement.
- Leadership roles in regional & national zero-emissions bus initiatives.

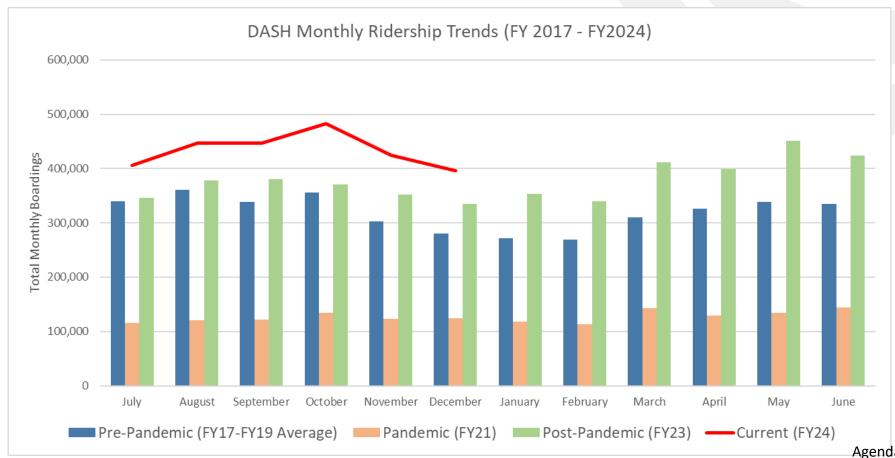
Overall:

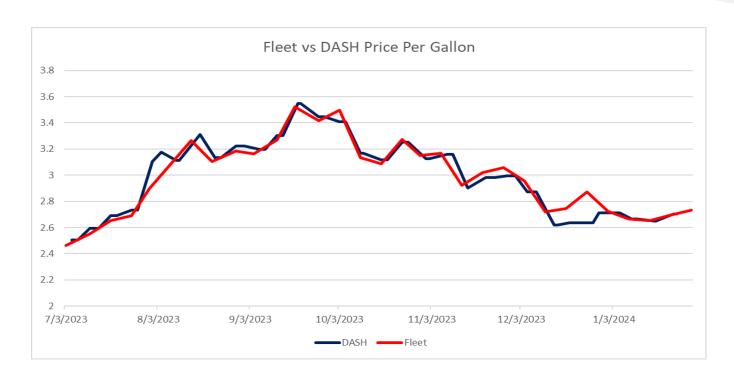
FINANCIALS

As of December 31st, 2023:

ATC is projecting a lowered year-end deficit of (~\$18,263), there are no significant changes from last months report.

Fuel Research Outcomes:

Identified as one of the leading challenges in budget adherence, the General Manager tasked staff with researching all possible options to create more stability in fuel prices. One possibility has been to piggyback on the City's fuel procurement process. Notably, in evaluating this option it is evident that the prices City Fleet pays for Diesel are in line with, if not sometimes higher than the prices paid by DASH.

LADREY SITE REDEVELOPMENT UPDATE

- Site approved for redevelopment with new multi-story senior housing.
- DASH bus stop changes:
 - SB Fairfax stop between Pendleton & Wythe to be relocated further north with new shelter and larger pad.
 - SB Fairfax @ Oronoco to be relocated to Pendleton with new bench and ADA pad
- DASH added Oronoco stop relocation to address concerns raised by Annie B. Rose residents & City Council.





ALEXANDRIA TRANSIT STRATEGIC PLAN (ATSP)

- New planning requirement for state funding from Virginia DRPT
- Replaces previous annual Transit Development Plan (TDP) process
- Major update every 5 years; Addendum updates for inbetween years.

- No changes to Board authority for service/fare change decisions

ADDITIONAL ATSP SERVICE CHANGES

- FY 2026 Improvements
 - Line 30 | improve midday, evening and weekend headways to 15 minutes.
 - Line 32 | improve weekday peak headways from 30 to 15 minutes.
 - Lines 103 & 104 | improve weekday peak headways from 30 to 20 minutes.
 - WMATA Better Bus Network Changes | TBD
- FY 2027 Improvements
 - Line 102 | improve weekday midday headways from 60 to 30 minutes.
 - **King Street Trolley** | extend routing from King Street Metro to Eisenhower Metro and extend operating hours from 11:00 AM to 6:00 AM.
 - West End Transitway | New BRT-style service to begin service and replace most of Line 35. West End Transitway service operator, service levels, and impact on adjacent DASH/WMATA routes to be finalized by late 2024.

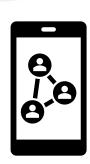
