



Balanced Budget & Fiscal Stability

- Second consecutive balanced year FY25 ended with a \$872,584 surplus (~2%).
- Reflects continued turnaround following FY24's first balanced budget in six years.
- Demonstrates strong financial management, accurate forecasting, and spending discipline.

Key Drivers of Results

- Surplus primarily linked to timing of City medical insurance transfers under DASH's self-funded plan.
 - DASH prudently reserved these funds pending reconciliation.
- Reforms in purchasing, operations supervision, and cost controls continue to deliver results.


